hereby and duly conclude, for the purpose of developing amicable relations in the field of training, education, culture and scientific research, the following Memorandum of Understanding:

# 1. Subject of Content

The subject of this Memorandum is cooperation between the above stipulated Contracting Parties partners in the following fields:

- 1.1. Exchange stays of pedagogues (long-term or short-term) for the purpose of implementing teaching process.
- 1.2. Exchange stays or internships of students and post-graduate (Ph.D.) students for various periods of time with the option of mutual recognition of credit evaluation.
- 1.3. Exchange stays of research workers for the purpose of mutual research and/or scholastic work, participation at conferences, seminars, presentations of reports or lectures.
- 1.4. Exchange of textbooks and technical literature, information on study programmes and teaching methodology.
- 1.5. Cooperation on organizing international scientific conferences, programmes, exhibitions.
- 1.6. Cooperation in the field of research and on creation, compiling and implementation of international projects.
- 1.7. Cooperation in the field of editing and publishing activities.

### 2. Duties of Memorandum of Understanding Parties

The Memorandum of Understanding parties undertake to create and provide the conditions required for implementation of this Memorandum, mainly:

- 2.1. Maintain in mutual and constant contact, facilitate exchange of necessary information and coordination of mutual work.
- 2.2. Continuously negotiate the results of all mutual activities, and subsequently present proposals of further cooperation. For this purpose, meeting(s) of the authorised representatives of both Parties shall be convened.
- 2.3. Implementing any form of cooperation (exchange, visit, teaching, and research) is will be dependent on the available resources and financial support, which each of the Parties will be able to allocate.

2.4. Individual particular projects within the Memorandum may be amended on the basis of concluded Amendments to the Memorandum.

## 3. Validity and Conditions of Memorandum of Understanding

3.1. This Memorandum of understanding into force upon its signing by both Contracting Parties.

3.2. The Memorandum of understanding is concluded for a period of 5 years and shall be automatically extended by for another term. All proposals pertaining to amendments to the contractual conditions herein, as well as withdrawal from the Memorandum, must be communicated by a Contracting Party to other Party in writing and within a minimum of 06 months prior to the expected date of amendments and/or withdrawal coming into force.

3.3. The conditions of implementing and financing particular activities on the basis of this Memorandum shall be subject to an agreement, as special amendments, duly compiled for each term and shall form an

integral part to this Memorandum.

3.4. This memorandum of understanding is determinant in relation to all other contracts, requirements (agreements) and protocols, concluded previously in written or verbal form, correlated to the subject of this Memorandum.

3.5. Unilateral denouncement of the Memorandum is possible in the event of non-fulfilment of the obligations/duties on the part of one of the Contracting Parties.

## 4. Liabilities of Memorandum of Understanding Parties

4.1. Both Memorandum of Understanding parties have equal rights and equal liability for adherence to the stipulated conditions of this Memorandum. In the event of any doubts on the interpretation and/or compliance with the stipulated conditions, both Contracting Parties duly commit to their substantial analysis and to the reaching of a mutually acceptable agreement in the spirit of further continuation of this cooperation.

4.2. Concerning relations with third parties, each Party represents itself. Neither Party shall bear any

responsibility for liabilities towards any third parties.

#### 5. Final Provisions

5.1. This Memorandum of Understanding is drawn and signed in duplicate whereby each Party shall receive one copy as original.

5.2. This Memorandum of Understanding comes into force and operation on the day of signing of both parties.
