of mutually cooperation between
Zhansugurov University (Republic of Kazakhstan)
and
Pallas University of Applied sciences
(Republic of Estonia)**

AGREEMENT

Taldykorgan c.

November 8, 2018

Zhansugurov University, represented by the Rector Prof. Dr. **Kuat Baimyrzayev** and Pallas University of Applied sciences, represented by the Rector Prof. **Valeri Nuust**, acting under the Charter, hereinafter referred to as "Universities" have concluded this Agreement as follows:

1. THE SUBJECT OF THE AGREEMENT

1.1. Organization and strengthening of cooperation between universities to share experiences of training and information on new technologies, training of specialists, the implementation of the exchange of students, teachers and academic staff to carry out joint activities within specialties of «Fine arts and drawing», «Design».

2. OBLIGATIONS OF THE PARTIES

Universities accept the following obligations:

2.1. Organize joint scientific and innovative research on important topics, to promote the commercialization of scientific research, develop and maintain contacts between departments, universities, laboratories;

2.2. Assist in the development of international cooperation through student organizations of universities;

2.3. Organize joint conferences, symposia, seminars at various levels, to exchange publications and other scientific materials and to inform each other about other ongoing research activities;

2.4. Carry out the training of qualified specialists in mutually agreed programs and the mutual participation of the parties;

2.5. Provide conditions for training researchers on agreed programs;

2.6. Provide employees the opportunity to use university research libraries university funds;

2.7. Provide students, undergraduates and PhD doctoral of the universities possibility of scientific training;

2.8. Provide advice in carrying out research work;

2.9. Exchange of students and teaching staff (students, undergraduates, graduate students and PhD students);

2.10. Development and implementation of joint educational programs, including double degree (dual diploma) programs.

3. OTHER TERMS

3.1. This agreement does not preclude other forms of cooperation that may be proposed on the initiative of one of the universities;

3.2. All changes and additions to this agreement shall be valid only on condition that they are executed in writing and signed by authorized persons of the two universities and presented in the original; According to some aspects of the project parties can sign an annex to this agreement.

3.3. All disputes and disagreements are resolved in accordance with applicable law;

3.4 This Agreement is made in two copies having equal legal force and takes effect upon its signing and is valid for five years;

3.5 Any of the university has the right to terminate this Agreement by written notification to the other university within one month before.

4. FINAL PROVISIONS

4.1. This Agreement is made in the English language in two copies. Both copies have equal legal force.

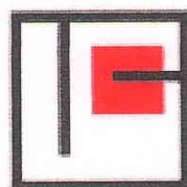

**ADDITIONAL AGREEMENT
to the cooperation agreement dated November 8, 2018 -
between
Zhetysu University named after I. Zhansugurov
(Taldykorgan, Republic of Kazakhstan)
and
Pallas University of Applied Sciences
(Tartu, Republic of Estonia)**

With the purpose of improving the established mutual relationship in the field of education and science, Zhetysu University named after I. Zhansugurov and Pallas University of Applied Sciences concluded this Additional Agreement No. 1 (hereinafter the Additional Agreement) to the cooperation agreement dated November 8, 2018 (hereinafter the Agreement) as follows:

1. Due to the reorganization of the RSE on the REM "Zhetysu State University named after I. Zhansugurov" of the Ministry of Education and Science of the Republic of Kazakhstan into the Non-profit Joint-Stock Company "Zhetysu University named after I. Zhansugurov", throughout the whole text of the Agreement, the name of the university should be replaced with "Zhetysu University named after I. Zhansugurov".
2. The Additional Agreement is an integral part of the Agreement dated November 8, 2018.
3. The terms of the Agreement not affected by this Additional Agreement remain unchanged.
4. This Additional Agreement is made in English language in two copies, one copy for each of the parties. Both copies have equal legal force.
5. This Additional Agreement takes effect upon its signing by the parties.
