



**MEMORANDUM OF COOPERATION**  
between  
**Zhetysay State University named after Ilyas Zhansugurov**  
**(Kazakhstan)**  
and  
**TALLINN UNIVERSITY**  
**(Estonia)**

The Zhetysay State University named after Ilyas Zhansugurov (hereinafter referred to as "ZHSU") and the Tallinn University (hereinafter referred to as "TU") recognize their desire to engage in cooperative educational and research activities for mutual benefits of both institutions. To expand and promote their mutual interests, both parties have agreed to encourage organizing the following:

- ZHSU invites the professor of TU Peeter Jarvelaid to the position of vice rector of innovative work and strategic development
- Joint curricular activities in education and teaching, such as joint educational programmes, diploma programmes, dual degree programmes and summer schools;
- Joint extra-curricular activities in academic and scientific fields, such as certificate courses, conferences and symposia;
- Collaborative research projects and studies;
- Collaborative academic and scientific publications;
- Exchange of undergraduate and graduate students;
- Exchange of research and teaching staff;
- Exchange of academic publications and scholarly documents;


**Terms of Cooperation:**

1. Cooperation terms for each activity implemented under this Memorandum shall be agreed upon by both parties in writing, prior to the initiation of that activity. Any such agreement will form an Appendix to this Memorandum.
2. This Memorandum will not result in any financial obligations. Each institution will be responsible for its involvement in cooperative activities and all such activities will be dependent upon the budgetary appropriations of the parties.
3. All activities shall be in accordance with the regulations and policies of ZHSU and TU.

**Renewal, Termination and Amendment**


1. Upon approval by each institution, this Memorandum shall remain in effect for a period of three (3) years. At the end of five years, this Memorandum will automatically be extended for another five-year period unless otherwise determined.
2. This Memorandum may be revised through the mutual agreement of both universities and may be terminated by either party upon giving six months written notice signed by the presiding office of the notifying party. All modifications to this agreement will be in writing, signed by both parties.

**ADDITIONAL AGREEMENT  
to the cooperation agreement dated April 30, 2018  
between  
Zhetysu University named after I. Zhansugurov  
(Taldykorgan, Republic of Kazakhstan)  
and  
Tallinn University  
(Tallinn, Republic of Estonia)**

With the purpose of improving the established mutual relationship in the field of education and science, Zhetysu University named after I. Zhansugurov and Tallinn University concluded this Additional Agreement No. 1 (hereinafter the Additional Agreement) to the cooperation agreement dated April 30, 2018 (hereinafter the Agreement) as follows:

1. Due to the reorganization of the RSE on the REM “Zhetysu State University named after I. Zhansugurov” of the Ministry of Education and Science of the Republic of Kazakhstan into the Non-profit Joint-Stock Company “Zhetysu University named after I. Zhansugurov”, throughout the whole text of the Agreement, the name of the university should be replaced with “Zhetysu University named after I. Zhansugurov”.
2. The Additional Agreement is an integral part of the Agreement dated April 30, 2018.
3. The terms of the Agreement not affected by this Additional Agreement remain unchanged.
4. This Additional Agreement is made in English language in two copies, one copy for each of the parties. Both copies have equal legal force.
5. This Additional Agreement takes effect upon its signing by the parties.
