The University of Gdańsk, seated at 8 Bazynskiego Str., 80-309 Gdańsk, Poland, and Zhetysu University named after Ilyas Zhansugurov seated at Zhansugurov str. 187a Taldykorgan, Kazakhstan, jointly expressing the intent to develop and promote cooperation in the fields of education and academic research, agree to the following:

- 1.1 to encourage exchanges and visits in the following categories: undergraduate and graduate students, non-teaching and post-graduate fellows, and faculty members;
- 1.2 to exchange information and materials in those fields which are of interest to both universities;
- 1.3 to facilitate communications, networking and arrangements made by faculty, administration or student organization leaders in the accomplishment of the above exchanges;
- 1.4 to organize joint training, summer programs, language courses, conferences and academic programs;
- 1.5 to facilitate joint research activities and publications;
- 1.6 to explore opportunities for double diploma programs in English;
- 1.7 to support each other in the field of international promotion and student recruitment.

2. The details for the implementation of these activities will be developed mutually for specific projects executed individually for each activity and regulated by legally and financially binding agreements.
